## VOLUNTEER CODE OF CONDUCT

In order to maintain a safe, healthy, and fun environment for our volunteers, staff, and shelter animals, I assert the following: *(Please initial each)*

- \_\_\_\_\_ I agree to follow all directions given to me by senior volunteers and staff while volunteering.
- \_\_\_\_\_ I agree to obey all signs posted in the shelter, especially those regarding the health or behavior status of the animals.
- \_\_\_\_\_ I agree to notify shelter staff or senior volunteers to let them know when I will be volunteering.
- \_\_\_\_\_ Should I need to cancel my shift, I agree to notify the shelter of my change of plans.
- \_\_\_\_\_ I agree to treat shelter pets, staff, clients, and volunteers with care, understanding, and respect.
- \_\_\_\_\_ I understand that I may be dismissed from volunteering for any reason, including, but not limited to, disruptive behavior, foul language or actions, physically assaulting a person or pet, or behaving in a way that could result in harm or a dangerous situation.
- \_\_\_\_\_ When walking dogs, I agree to keep them on leash and under control at all times.
- \_\_\_\_\_ I understand that animal issues may come up unexpectedly and volunteer shifts may need to be cancelled or postponed from time to time. As much advance notice as possible will be given to our volunteers in the event this occurs.
- \_\_\_\_\_ If my child is a volunteer, I agree to volunteer with my child and not leave them unattended with animals at any time.
- \_\_\_\_\_ If my child proves disruptive or is creating a dangerous situation as described above, I understand that I may be asked to remove my child.
